Welcome all back to SWROGA! After about a six-year period with no newsletter, we have restarted it to keep our members updated on the latest meetings and happenings in SWROGA.

We would like to congratulate the Houston Orchid Society for hosting a wonderful Spring SWROGA show in Houston in March. As we move forward, we need a host for the Fall 2024 SWROGA meetings. Do you know how widespread an area this Association covers? We include Orchid Societies from Arkansas, Kansas, Louisiana, Oklahoma, and Texas with 21 societies represented. Each person is also a member of SWROGA if their society belongs to SWROGA, which at last count we are about 1000 individuals.

What benefits are there in being a SWROGA member?

SWROGA supports societies hosting the semi-annual fall and spring SWROGA meetings and shows. We provide funds for trophies to the hosting society so they can provide great trophies to the winners. SWROGA provides a show entry schedule and classification that is used as published for SWROGA events. Most societies use the schedule as published or modified as they wish for all of their shows. This provides consistency so members can enter their plants easily across the region. SWROGA has a committee responsible for updating the schedule based on number of entries seen in each class and especially based on the official name changes from RHS. We also print and distribute the two-part show entry tags. These tags are ordered via the SWROGA website at a nominal cost.

SWROGA ACHIEVEMENT AWARD

This is to explain an honor you may or may not be fully familiar with, the SWROGA Achievement Award. This award was created subsequent to the efforts of an ad hoc committee chaired by Lena Parker in 1992. The purpose of the award is to recognize extraordinary members and their efforts in behalf of SWROGA.

Conditions and procedures are that any member can nominate a potential recipient (living or deceased). Nominations are made by letter to the SWROGA President, and should list the nominee's accomplishments. The letter must be received by the Continuing Operating Committee at least 60 days prior to the next meeting to be considered. The letter is then circulated to SWROGA officers for their recommendation. If recommended by the officers, the nomination is presented to the Board of Directors for approval, to be presented as soon as possible.

NEW TROPHY CLASS IN SWROGA SCHEDULE

Youth Exhibit

A new Class and Trophy was passed by the membership at the Spring 2024 SWROGA meeting. This was passed to encourage youth participation in shows. It entails adding a new definition to the Show Rules and Regulations, Section 8. Classification, number 'h' defining what is a youth exhibit and a youth exhibitor.

This new Class was added to the Non-Commercial Exhibit Classes.

New language added to Full Exhibit Shows and Tabletop Exhibit Shows.

- 8. Classification. For trophy classes 919-948, the following definitions will apply:
- h. Youth Exhibit Exhibitor must be under the age of 18. The exhibit may consist of plants, cut flowers, and/or collectibles, which must come from the Exhibitor's household.

Exhibits Non-Commercial 919. Best Youth Exhibit. (Trophy)."

This addition to the show schedule was approved and adopted.

SOUTHWEST REGIONAL ORCHID GROWERS ASSOCIATION 125th Directors and Membership Semi-Annual Meeting Spring 2024 Memorial City Mall, Houston, Texas March 9, 2024

Call to Order

- The SWROGA Directors and Membership meeting was held both in person and via Zoom in the Memorial City Mall, Houston, Texas.
- Acting President, Sarah Pratt, called the meeting to order at 11:30 AM(Saturday) and welcomed all
 officers and directors as they acknowledged attendance. Thanks were given to the Houston Orchid
 Society for hosting the Spring SWROGA show.
- Sarah Pratt reported the presence of a quorum with 10 societies represented and a total of 12 directors in attendance as well as the officers shown below.

Approval of minutes:

Sarah asked for corrections or additions to the October 7, 2023 meeting minutes previously emailed to all directors and society presidents, officers, and committee chairs. Sarah stated with no opposition, minutes are approved.

Treasurer's Report:

Charles Hess

The spring Financial Reports consists of two statements: **Account Balances** and **Cash Flows** for each of our six SWROGA Funds for the period of Oct 1, 2023, to Jan 31, 2024 (Four months into our 2024 fiscal year). These statements are reported separately.

Account Balance Statement highlights:

- Investments in the <u>SWROGA Operating Fund</u> are shown to have increased to \$14,000 with the addition of a **new** \$5,000 Duke Energy corporate bond yielding 5.4%.
- Of the total available cash in the <u>SWROGA Operating Fund</u> (\$7,956), **\$5000 could be invested long term** (Finance Committee to review).
- The <u>SWROGA Endowed Trophy Fund</u> now has an \$85,000 balance showing in our investment account (Note 3). This is down \$10,000 due to the maturity of our GE bond. Past financial reports had the maturity date erroneously shown as Sept 2025. The actual date was January 2024.
- The total Available Cash in the Endowed Trophy Fund now indicates \$15,000 could easily be invested (Finance committee Action Item). A \$5000 CD maturing is also part of this amount.

SWROGA Fund Cash Flow highlights:

- The <u>SWROGA Conservation Fund</u> income shows the success to date for the new annual fundraising project. Individual donations have been strong, and we even have our first donation to the new Magrath Memorial fund. Total raised is \$2,200 as of this statement date.
- For the <u>SWROGA Research Fund</u> made its first \$1000 stipend disbursement to support the Cedar Ridge Preserve's annual Hexalectris survey.

Sarah asked for any opposition to the Treasurer's report and with none the report was approved.

Dr. Lawrence McGrath Memorial Fund

The following procedure was previously issued for review:

"SECTION K – MEMORIALS

THE DR. LAWRENCE MAGRATH MEMORIAL /CONSERVATION FUND

Societies or society members may elect to have the name of a deceased member listed for remembrance in the annual SWROGA Directory in the index section IX immediately following Dr. Magrath's poem of remembrance "In Memoriam".

Remembrances will be listed in descending order by calendar year of death with the most recent year immediately following the poem and under the fund title above. The member's name and then society will accompany the year.

Requests will be honored with a donation of any amount made out to SWROGA with the name of the person being memorialized, society, and calendar year of death in the check's memo field which will indicate a donation to this fund. Multiple donations for a specific person will be recognized in the treasurer's report.

The SWROGA treasurer will notify the Directory Manager of the new names to be listed as described above. The most recent 2 years will be listed in the Directory and a complete list will be archived by the Historian and listed on the SWROGA website.

Donations will go to the SWROGA conservation programs in recognition of Dr. Magrath and his conservation efforts for SWROGA. "

With no corrections or opposition, this addition to SWROGA procedures was approved and adopted.

Newsletter

Eron Borne has volunteered to revive the SWROGA Newsletter. Once resumed, the Newsletter will be available on the SWROGA website.

New Business:

Procedure Revisions

The following procedure was previously issued for review:

"SECTION A – CONSERVATION

CONSERVATION REPRESENTATIVE

Each affiliated society should appoint a local Conservation Representative to exchange information between SWROGA and their society. The name, mailing address, email address, and telephone number of the local Conservation Representative should be included in the SWROGA Directory in the list of Officers.

CONSERVATION COMMITTEE

The SWROGA Conservation Committee shall consist of all affiliated society Conservation Representatives and any other society member wishing to participate.

ORCHID HABITAT SUPPORT

SWROGA conservation financial support is to be solely voluntary through society donations and individual member donations.

SWROGA societies may select a local orchid area or preserve to receive SWROGA support and specify that their society's SWROGA Conservation Committee donations go to these preserves.

The orchid preserves currently receiving annual SWROGA support are:

- (1) Watson Rare Native Plant Preserve- a 10 acre preserve near the Big Thicket in East Texas most noted for its large population of Platanthera chapmanii.
- (2) Cedar Ridge Preserve- Located 30 miles south of Dallas and known for its large population of Hexalectris warnockii (The official SWROGA logo orchid).

TYPES OF SUPPORT

Support for native orchid habitats within the SWROGA region may be in three forms: direct financial support, research stipends (indirect), or volunteer work. "

With no corrections or opposition, this addition to SWROGA procedures was approved and adopted.

Procedure change on Section C – Membership

The subject procedure was previously circulated for review. Alison Gallaway moved to include an increase in member dues to \$30 per annum for each affiliated society. Due to its length the revised procedure is appended as Attachment A. The procedure as amended was approved by majority vote (10 to 2).

Update on SWROGA Show Schedule for Oncidium Alliance

The proposed revisions to the Oncidium Alliance classes 402-434 and including a color photo attachment were previously circulated for review. Sarah Pratt thanked the team, Alison Gallaway and Karl Varian, for the work on this update. With no opposition this change was approved. Due to the photo inserts, this revision cannot be included in this document and will be transmitted concurrently.

Website Update

The SWROGA website now has links available to access the AOS, SWROGA Judging Centers, and SWROGA Affiliated Societies. In June the SWROGA Officers and Committee Chairs will be listed with methods to contact them by email. The Newsletter when available will be on the website. Work is ongoing for adding the Directory of Affiliated Societies' officers and members to the website. There are security issues with this that must be resolved.

A Co-Administrator is needed for the website. Affiliated Societies are requested to poll their members for a volunteer who has experience in website management and WordPress.
