President Lloyd Burns called the semi-annual and distribution
Spring 2005 SWROGA meeting to order at 10:40 am needs to know after being assured that a quorum was met by Registrar Billie Beck Kramer. The President then offered a gracious welcome to all attendees and hoped many had enjoyed the beautiful drive through the mountains as had

Lena Parker made a motion to approve the Minutes of the previous meeting as published in the Winter 2004 SWROGA Newsletter. Motion was seconded by Lowell and approved by Director vote.

Carolyn McCabe, Treasurer, presented the Semi-Annual Financial Report for the period ending March 31, 2005. A new Section as been added for the new Research Fund with Funds on Deposit being \$560. The accounts Total Funds are \$75,159.76. Membership dues increased this year to an amount of \$4,046 up 36 Members from this time last year. Newsletter outlay costs for the Winter and Spring issues were \$1,917.26. A motion to approve the Minutes was made by Mavis Klehm and was carried by the Directors.

President Burns called for the Reports of the Standing Committees:

Committee discussed Society loss and will endeavor to
find ways to re-incorporate the Societies and recruit new
ones. Report was approved and filed.
Byron McGraw, Chair of the Bylaws and Judiciary
Committee met earlier today with 2 Members with 1
excused absence. They discussed with the President,
Vice-President, and Treasurer a number of concerns
regarding the financial condition of SWROGA. The

The Committee Chair reminds the other established committees that the SWROGA Bylaws were designed to establish committees to function accomplishing necessary action required. All committees were urged to review the Bylaws to ensure that their primary function was being performed. The addition of another function is not precluded provided it does not interfere with the primary function of the Committee, or the functioning of other committees. Motion made by Mickey Parker

Jim William's Conservation Committee had 4 Members present at today's meeting. He stressed the need to preserve the unique lands upon which native species thrive through the cooperation and coordination of agencies and private land owners. Relocation of species is not always a good solution. Some societies are publishing articles of significance on native species in their newsletters. In coordination with the Publications

Committee the latter will pursue the possibility of posting Societies' newsletters on the SWROGA website for all to access. Committee Member Ron Hazelhuhn of the Kansas OS is recompiling and revising, as may be necessary, his State's native species list with pictures

and distribution maps...a good objective of all states! Jim needs to know the name of your Conservation Rep if it is not documented in this year's SWROGA Directory. Societies should consider Native Species Tours by piggybacking onto other broader group tours, such as Audubon birding groups and Natural History Museum tours. Take advantage of local area expertise and continue its development. Network with other naturalists, especially if development. Patsy Boersma, Chair of the Programs and Education Committee, reports 2 members were present at their meeting earlier. The Slides List and Speakers List were discussed. The latter has been updated thanks to the helpfulness of supportive Members. GOOD PROGRAMS ARE THE LIFE BLOOD OF OUR SOCIETIES. Betty Kurka, our Librarian, continues to evaluate our many outdated slide programs. If you have a program in the directory please update if or it may be discarded. A Society pays \$15 for postage to rent a Slide Show and negative feed-back is too common. NEW SLIDE SHOWS ARE NEEDED! Report was accepted and filed. Lowell McCabe, Chair of the Show Committee reports it is hard to please everyone all of the time but the Show Committee tries hard and does its very best. He reminds the Societies that they are forbidden to delete a class in the Show Schedule but they may add or expand a class for their show only after submission, review, and approval by the Committee. Class 342 has been dropped as a result of so few entries. Lois recommended expanding Class 341 to incorporate 342. The Committee will take her recommendation into consideration. When requesting a SWROGA Show Schedule obtain it directly from Lowell via e-mail or USPS mail. Do not download it from the SWROGA website. Lloyd reminded members that the Alpha List of Species and Intergeneric Hybrids is Kurka, our Librarian, continues to evaluate our many outfrom the SWROGA website. Lloyd reminded members that the Alpha List of Species and Intergeneric Hybrids is included as a supplement with the Show Schedule. This is an index for plant entries and should be referred to for proper plant classification! Also, Lowell stressed the importance of reading and being familiar with the Preface to the Show Schedule. Mickey motioned to approve report. Motion carried. Report filed.

Dick Jamison, Chair of the Research Committee,
distributed a one and a half page typed document
"SWROGA FUND FOR RESEARCH" "Proposed
Procedures to be followed by the Research Committee".
This procedural vehicle, referred to at our prior meeting, is intended as a guide for a working procedure to determine grant eligibility. It is intended to be a "start" and is "not in stone". Chairman Jamison gave the Directors and Members a brief synopsis of the document and its intentions. Byron McGraw made a motion wanting the By Laws Committee to review the document prior to voting on it. This motion was seconded by Lois.
Opposition requested that this motion be tabled. Opposition requested that this motion be tabled. Discussion ensued. Wally was concerned about any

government prohibition. Byron was not seeking to approve or disapprove the document; he just wanted it reviewed prior to voting. A motion was made by Mickey Parker to accept the procedural document as presented today. Ruth Wright requested to amend Mickey's motion to allow review of the document by Byron's By Laws Committee before a vote is taken. This motion was seconded by Carolyn McCabe. There was a call of Question on the Amendment to end debate and vote on the motion made by Mickey. Opposition carried. A vote was called. Majority voted to accept the procedural document as presented. Byron has requested that the minutes make note of his opposition to the vote at this time. The document is attached hereto and made a part of these Minutes.[Editor's Note: The document was filed by the Secretary with the other reports, and is not printed in this issue of the SWROGA News.]

There were no reports from Ad Hoc Committees.

The President called for Reports of Continuing Functions. Historian Betty Kurka brought and had distributed 6 issues of ORCHIDS magazine at the Show. She is unable to find documentation of the names of SWROGA Presidents from 1962 to 1977.

Lowell McCabe reported on Show Tags. Show Tags are prepackaged at 250/pkg. The Societies' \$35 standard cost covers 2 packages (500 tags) plus shipping. The last 1500 tags were not legible and had to be returned. We have about 15K tags on hand. Our order requests that the bottom sheet of the NCR show tags be thicker and extra firm. An error was made at the printer and when corrected we were shipped an additional 20K tags at no cost to us. SWROGA came out ahead. Registrar and AOS Rep Billie Beck Kramer had no reports.

There was no Old Business.

A Nominating Committee of Mickey Parker, Lois Dahlsberg, and Wayne Marine will present a Slate of Officers at the next meeting.

A motion was made by Lowell McCabe to rescind the requirement to return \$35 Trophy money if trophy is not awarded at a Society's SWROGA Show. A brief discussion ensued. Mickey noted that Societies were not spending the full \$35 but the problem has since been resolved. Question was called and debate ended and a vote was called. Motion carried to rescind requirement to return funds.

Meeting adjourned at 11:45am.
