AN END OR A BEGINNING? By Ed Wright

Recently, I have learned that Dr. Yin-Tung Wang must virtually eliminate his orchid talks to our societies and meetings. Dr. Wang has not asked for my support or intervention, but I learned during discussions of his work that he has recently been forced to cover expenses for his speaking engagements from his own pocket, using his vacation time to cover travel for this purpose. At a recent meeting, I was shocked to learn that Dr. Wang had to rent a car from his own means to cover a commitment he had made months ago. None of us could continue to serve on this basis and, in fact, he has honored his prior commitments far longer than most of us would be able to do.

Through various contacts in education, USDA, commercial nursery production and other activities, I have pieced together a view of this situation that seems to fit the evidence. As I see the situation now, those who administer policy over the Agriculture Experiment Station in Weslaco, where Dr. Wang and many other scientists do their primary work, have decided that orchid research, as a subject is not an appropriate area for inquiry by the Station. Orchid production, in the sense of crops produced, is a minor industry in Texas. That being the case, organized support for orchid research may appear to be lacking when compared to food crops, for example. In other words, the orchid business is divorced from the great agricultural production industry in Texas, where cotton, rice and maize hold star billing.

If one is satisfied that 'production is king', perhaps there is no more to be said. By the same token, one must acknowledge that orchids represent the #2 cash-generator among flowering plant sales. People like Dr. Wang have made that happen. Work with Phalaenopsis alone brought orchid retail sales from the hundreds to the hundreds of thousands nationwide. Texas retailers received and continue to receive their share of this bounty. We speak of Texas here because that is where the immediate battle is found. I don't think any of our regional orchid enthusiasts will have trouble deciding that the Weslaco problem will impact them just as directly as it will impact the Texas orchid industry. I think it is urgent that we, as orchid people, stand up to the academics and demand consideration of economic impact on a par with production impact. It may be a Texas problem today, but it will surely be a regional and then national problem soon.

My suggestion: write every person you know who holds public office or is in any way connected with Texas education, USDA services, the Extension Service or the Agricultural Experiment Station in Weslaco. Let them know that you think the market for orchids is an important one to you, your state and the nation. Explain how horticultural crops tend to generate sales tax return while food crops and exported crops do not. Suggest that a broader view will put money in retail coffers in Texas and every other state where orchids are the reining year-around money producer.

Every word above is mine. I have developed my opinion based upon years of work with commercial nursery interests. I do not speak for Dr. Wang, nor do I speak for or against any person connected with the Agricultural Experiment Station in Weslaco, Texas. By the same token, if I can help in this matter, please let me know.

WRIGHT THINKING By Ed Wright

Tax time is good for something, at least: it forces us to look at old records. I was tracing a business transaction the other day when I ran across some notes I made during a visit with Bill Barfield thirty or more years ago. Back in them days, as they say, Bill was a lone voice of reason about air pollution problems. A geologist and man of science, Bill was well-qualified to speak. A year would not have been complete without Bill appearing before the Corpus Christ City Council, dumping a box of blighted orchid blooms on their pristine conference table and proclaiming Corpus Christi air to be a leading example of the most polluted in the country.

Somewhere back in the Vietnam era, I joined Bill in taking the same message to a hearing of what I recall as the 'Air Quality Board' in Austin. What I specifically recall is that the committee made us wait until full dark to appear and then gave the impression of no interest in anything but getting home for dinner.

Bill and I are off the scene now, but the lonely fight is carried on by people like Suzie Canales, in Corpus Christi. No cut flower producers besiege city hall with flowers spoiled by ethylene-induced sepal wilt or spots burned into petals by free air acid droplets. We just breathe the stuff and trust 'the gummint' will tend to the problem. What problem? Let me show you.

For 2004, the last year for which figures are available to me, here's what the nation's air pollution data showed (bold type mine):

- 5 Lyondell Chemical Co., Lyondell-CITGO plant, Houston, TX
- 6- EXXON-Mobil Baton Rouge refinery, Baton Rouge, LA
- 7- Valero refinery, Corpus Christ, TX
- 8 Sunoco plant, Philadelphia, PA
- 9 EXXON-Mobil refinery, Chalmette, LA
- 10- CITGO plant, Lake Charles, LA

No, I'm not going to defend the Environmental Integrity Project. Each person must evaluate that issue on his own. What I am going to do is point out that all but one of these leaders pollute air in SWROGA territory. Granted, BP says they made a reporting error on the 2004 data, and besides most of the problem was an accidental emission of 1.9 million pounds of formaldehyde. That certainly should make everything right. Heck, this isn't even the crud that stains your laundry; it's just cancer-causing carcinogens and stuff like that.

Bill Barfield tried to tell us: this pollution is occurring because companies can locate in this area and get away with unbelievable disregard for the environment, for our health and yes, for our flower quality. For one more time, I am supporting Bill's position: we are not talking about flower quality; we are not talking about quality of life; we are talking about life itself.

I am certainly not advocating that SWROGA become a special interest political action committee. That would violate our charter, bylaws and purpose. I am suggesting that a coming generation of little SWROGAns depend upon YOUR demands for reasonable air quality standards for our selves and for our environment.


