President's Message

Southwest Regional Orchid Growers Association Directors and Membership Meeting Minutes April 2, 2011

The SWROGA Directors and Membership meeting was held in the Holiday Inn South, Baton Rouge, Louisiana on Saturday April 2, 2011. President Lowell McCabe called the meeting to order at 11:03 a.m. Carolyn McCabe reported that there were 14 societies present out of 27 member societies. A quorum was declared.

The minutes of the previous meeting were approved and seconded.

Committee Reports

<u>Affiliated Societies Committee</u>: Lena Parker reported that we had raised \$115 on our raffle and reminded us about the auction in the evening. Next SWROGA show will be in fall 2011 in San Antonio, the following spring 2012 show will be in Kansas. There are additional open slots in the future that need to be filled.

Continuing Operations Committee: No report.

<u>Programs and Education Committee</u>: Patsy Boersma reported that we have begun transferring talks to Power Point format.

<u>Show Committee</u>: Don Maples reported revision of the Genera List, as pertaining to new genera designations is a work in progress.

<u>Auditor</u>: Not present.

<u>Treasurer's Report</u>: Carolyn McCabe presented the Annual Financial Report for approval. She noted that one bond had matured. Those funds together with an additional \$500 were put into a GE bond – 15 yr, 4.5% interest. Other CDs will be maturing and will be dealt with as needed.

Lena Parker moved we add \$5,000 from the General Funds to make a \$10,000 Bond for the next maturing CD. The motion was seconded and passed. Motion to accept the Financial Report was made, seconded and approved.

New Business

Nominating Committee consisting of Sheila Skov, Lena Parker, and Linda Horton was approved.

A three-person ad hoc committee consisting of Don Maples, John Stubbings, and Jake Massey was appointed to look at new timing of judging and meetings at future SWROGA shows.

Chair vacancy for the Affiliated Societies Committee was announced.

Chair vacancy for the Conservation Committee was announced and filled by Linda Horton.

Dick Jamison announced that the Shreveport JC was looking to establish funding for a Memorial Trophy in honor of Lloyd Burns. Please see Byron McGraw to help.

No further new business. The Meeting was adjourned.
